CHANGES IN PROCESSING REQUESTS FOR COPIES OF NATIONAL ARCHIVES RECORDS

Effective May 1, 1984, all requests for copies of military service records or passenger arrival records must be submitted on NATF Forms 80 and 81, respectively. After May 1 prior versions of these forms (NATF Form 26 and NATF Form 40) will not be accepted for processing. All forms other than the NATF Form 80 or NATF Form 81 that are received after May 1 will be returned. A change in payment policies will also take effect May 1, 1984. NARS has in the past required that payment accompany requests for copies of veterans records and passenger arrival records. After May 1, 1984 payment should not be sent with the NATF Forms 80 and 81. NARS will research the request, prepare copies of any records located, and HOLD THE COPIES for 30 days or until payment is received, whichever is sooner. As soon as records are located and copied, researchers will receive a bill and instructions on returning their remittances. Researchers should also submit a separate NATF-Form 80 for each file (pension or bounty-land or compiled military service) desired. Previously researchers could ask for multiple files on one form. This change is designed to facilitate processing by the National Archives. Anyone interested in obtaining copies of the NATF-FORMS 80 or 81 may do so by writing to the following office:

On March 7, 1984 Marriage Book #17 was received at the Morrow Co. Probate Court from Barrett Brothers Publishers, specialists in legal forms since 1860. A typical court journal, with over 600 pages and weighing 22 pounds, the price tag was also hefty: \$480. To compare with the past, the Administrators and Executors Docket #4, about the same size and weight, was delivered to the court on February 1, 1879 for \$21.



The following guides reprinted by permission of the St. Louis Genealogical Society, 1695 South Brentwood Blvd., Suite 203, St. Louis MO 63144. This society was formed in 1966, and currently has a membership of about 2200, with one-fourth living in the St. Louis Metropolitan area. Regular membership is \$7 per year, with \$1.00 each for additional family members. Benefits include a monthly newsletter, a quarterly publication (with one free query a year), a list of their library holdings, and inclusion in their yearly Surname Index. TIPS ON TRACING YOUR FAMILY TREE

- 1. YOUR'RE NUMBER ONE. Start with yourself; your full name, date of birth and other important dates, the full names and dates of your parents.
- 2. KEEP THE RECORD STRAIGHT. You may use file cards, loose-leaf notebook, or another system. Enter all the information you find so that you can find it again when you need it.
- 3. ONE STEP AT A TIME. Prove the facts as you go; don't skip generations. You can't prove that John Henry Morgan was your great-grandfather unless you can show positive evidence that your grandfather was his son.
- 4. PENCIL VERSUS PEN. You need both. Keep unproved records in pencil so they can be changed. Don't make a permanent record till you're sure.
- 5. IT'S A FAMILY AFFAIR. Enlist the help of relatives. If they're nearby, visit them. If they're far away, write. Get reacquainted with distant cousins; learn their family traditions. Ask questions.
- 6. DATES ARE VITAL. Exact dates of birth, death, marriage may be found in family Bibles, on tombstones, in state, federal, or local records. Approximate ages appear in the census. Try every source.
- 7. "THEY WENT THATAWAY" . . . whichaway? Census records since 1850 show state of birth, family migration. Newspaper obituaries, county histories, some land and probate records also give clues to residences.
- 8. WHERE THERE'S A WILL . . . probate records can be proof positive of a relationship. Even when there's no will, records of estate settlements may show heirs and relationships.
- 9. NAMES ON THE LAND. Land transactions have been recorded with great care through most of our history. Records of deeds may show not only owners but heirs and relationships on both sides. Tax lists help, too. And look at the neighbors—they might be relatives.
- 10. PENSION PAPERS PAY DIVIDENDS. They're full of dates and places. If ancestor served in any war, it's on record; you can get a copy.
- 11. CHECK THE CHURCHES. Some denominations kept baptismal, marriage, burial records; others didn't. But some who didn't may have adjacent cemeteries with the data you need carved in stone.
- 12. LEARN TO LOVE LIBRARIES. For it may be that much of the research you need has already been done and is waiting for you right in your local library . . . in printed books or on microfilm.
